- Developing and continuing supporting our new PTA (Parent Teacher Association) at St Mary's in order to develop a community spirit and raise vital funds for our school.
- Reviewing and updating of the school development plan
- Sharing governors training experiences
- Introducing and inducting new governors

- Improved communication
- Holding a link governors visit event together with a Mass with the teaching staff
- Reviewing and maintenance of school site and surrounding environment, particularly with regard to safeguarding, with extra measures in place in the staff car park
- Continuing the schedule of policy review and agenda cycle
